

**RESOLUTION 2019-11  
COEUR D'ALENE AIRPORT/ADOPTION OF  
2019 RULES AND STANDARDS**

**WHEREAS**, Kootenai County owns and operates an aviation field known as the Coeur d'Alene Airport; and,

**WHEREAS**, on March 27, 1991, the Kootenai County Board of Commissioners adopted Resolution 1991-18 which addressed the Rules and Regulations governing the use and operation of the Coeur d'Alene Airport and set minimum standards for commercial aeronautical activities conducted at the Airport; and,

**WHEREAS**, it is the desire of the Kootenai County Board of Commissioners to continue to promote and maintain a safe aeronautical environment which will serve all individuals using or frequenting the Coeur d'Alene Airport in compliance with all current FAA Rules and Regulations; and,

**WHEREAS**, in order to protect and maintain the security of the aviation public, Airport personnel, aircraft, vehicles and personal property located on the Coeur d'Alene Airport grounds, it is the position of the Kootenai County Board of Commissioners that all would be better served by the adoption of revised and updated safety standards relating to any aeronautical activities and aircraft operation conducted at the Coeur d'Alene Airport; and,

**WHEREAS**, the Director of the Coeur d'Alene Airport has worked diligently with the Kootenai County Board of Commissioners and the Airport Advisory Board to revise and update the Rules and Standards which have been in place since March 1991; and,

**WHEREAS**, the Director of the Coeur d'Alene Airport has proposed the adoption of the 2019 Kootenai County Coeur d'Alene Airport Rules and Standards, a copy of which is attached hereto and incorporated herein as Exhibit A.

**NOW THEREFORE, BE IT HEREBY RESOLVED** that Resolution 1991-18 adopting the 1991 Rules and Regulations of the Coeur d'Alene Airport and the Minimum Standards for Commercial Aeronautical Activities is hereby repealed; and,

**BE IT FURTHER RESOLVED** that the Kootenai County Board of Commissioners does hereby adopt the 2019 Kootenai County Coeur d'Alene Airport Rules and Standards as incorporated into this Resolution, and directs that said Rules and Standards shall be considered as the governing authority for all aeronautical activities undertaken at the Coeur d'Alene Airport effective February 26, 2019.
