AMENDMENT TO MEMORANDUM OF UNDERSTANDING

This AMENDMENT TO MEMORANDUM OF UNDERSTANDING (the “Amendment”), dated effective as of the date of last signature hereto (the “Amendment Effective Date”), is by and between Kootenai County, a political subdivision of the State of Idaho (“County”), and North Idaho Day Surgery, LLC, an Idaho limited liability company, d/b/a Northwest Specialty Hospital (“NWSH”) (when referenced generally herein, County and NWSH are individually, a “Party,” and collectively, the “Parties”).

WHEREAS, County and NWSH entered into that certain Memorandum of Understanding , dated effective as of December 7, 2018 (the “MOU”) for those services more particularly set forth in the MOU; and

WHEREAS, County and NWSH desire to extend the term of the MOU and to take such action as is more particularly set forth herein,

NOW THEREFORE, the parties agree as follows:

1. The above-referenced recitals are true and correct and are incorporated as though fully set forth herein.
2. The MOU is hereby renewed and extended for an additional year, commencing December 7, 2023, and concluding on December 6, 2024.
3. Section VI of the MOU shall be updated to read as follows:

**COMMENCEMENT DATE, TERM.** The initial term of this MOU (“Initial Term”) shall be for five (5) years, commencing on the date of last signature. Following the Initial Term, the term of this MOU shall automatically renew for successive terms of one (1) year each, unless or until terminated by either Party as set forth herein (each such period, a “Renewal Term” and, together with the Initial Term, the “Term”).

4. All other terms of the MOU not heretofore amended shall remain in full force and effect.
5. Any capitalized term not otherwise defined in this Amendment shall have the meaning given such term in the MOU.
6. This Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original copy of this Amendment and all of which, when taken together, shall be deemed to constitute one and the same amendment. Counterparts may be delivered via facsimile, electronic mail (including pdf or any electronic signature complying with the U.S. federal ESIGN Act of 2000, e.g., [www.docuSign.com](http://www.docuSign.com)) or other transmission method and any counterpart so delivered shall be deemed to have been duly and validly delivered and be valid and effective for all purposes.
7. The exchange of copies of this Amendment and of signature pages by facsimile transmission (whether directly from one facsimile device to another by means of a dial-up connection or whether otherwise transmitted via electronic transmission), by electronic mail in “portable document format” (PDF) form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, or by a combination of such means, shall constitute effective execution and delivery of this Amendment as to the Parties and may

be used in lieu of an original Amendment for all purposes. Signatures of the Parties transmitted by facsimile or other electronic transmission shall be deemed to be original signatures for all purposes.
