

**RESOLUTION NO. 2025-20**

**In the Matter of Establishing Election Precincts pursuant to  
Idaho Code § 34-301**

WHEREAS, the Board of County Commissioners is required by Idaho Code § 34-301 to establish a convenient number of election precincts; and,

WHEREAS, the number of registered voters in certain precincts had increased to such size that the administration of elections was negatively affected; and,

WHEREAS, the combinations of Taxing Districts within certain precincts made it prudent to review these Precinct boundaries; and,

WHEREAS, a court-ordered precinct was created for the November 2024 Election, resulting in the need to remove this precinct for future elections.

NOW THEREFORE, IT IS HEREBY RESOLVED that the Kootenai County election precincts be established as shown on the attached maps and numbered as follows:

Legislative District #2 – 201, 202, 203, 204, 205, 206, 207, 208, 209

Legislative District #3 – 301, 302, 303, 304, 305, 306, 307, 308, 309, 310, 311, 312, 313, 314, 315, 316, 317, 318, 319, 320, 321, 322, 323

Legislative District #4 - 401, 402, 403, 404, 405, 406, 407, 408, 409, 410, 411, 412, 413, 414, 415, 416, 417, 418, 419, 420

Legislative District #5 - 501, 502, 503, 504, 505, 506, 507, 508, 509, 510, 511, 512, 513, 514, 515, 516, 517, 518, 519, 520, 521, 522

The newly adopted precincts shall be adopted and effective this day, and will be in effect for the May 20, 2025 Consolidated Election.

BE IT FURTHER RESOLVED, that the Kootenai County Clerk and Auditor is hereby authorized to commence with all necessary speed to implement the changes necessary to effectuate the implementation of this resolution, including but not limited to beginning the data conversion process for any and all precincts.


