

Resolution 2018-36
Surplus Vehicles – Grants Management/Transit Office

WHEREAS, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

WHEREAS, *Idaho Code* §31-808 provides that a board of county commissioners shall have the power and authority to sell or offer for sale at public auction any real or personal property belonging to the county not necessary for its use.

WHEREAS, Kootenai County Grants Management/Transit Office desires to dispose of the following three vehicles:

1. A 2010 Ford Starcraft Paratransit Bus (#410), Asset #4944, Serial Number 1FDFE4FS3ADA58590, which has been fully depreciated but with an appraised value of \$1,678; and
2. A 2010 Ford Starcraft Paratransit Bus (#310), Asset #4943, Serial Number 1FDFE4FS2ADA58600, which has been fully depreciated but with an appraised value of \$545; and
3. A 2010 Ford Starcraft Paratransit Bus (#210), Asset #4953, Serial Number 1FDFE4FP1ADA33246, which has been fully depreciated but with an appraised value of \$2356,

all of which have outlived their useful life for the Grants Management/Transit Office; and

WHEREAS, the vehicles described hereinabove are in poor condition, and have been offered to other County departments and entities pursuant to the Excess Personal Property Policy; and

WHEREAS, the Fair Board has expressed interest in Bus #210; and

WHEREAS, the Grants Management/Transit Office desires to have the Board of County Commissioners transfer Bus #210 from its asset list to the asset list of the Fair Board;

NOW THEREFORE, IT IS HEREBY RESOLVED that the 2010 Ford Starcraft Paratransit Bus (#210), Asset #4953, Serial Number 1FDFE4FP1ADA33246 be, and hereby is, removed from the Kootenai County Grants Management/Transit Office's asset list and transferred to the Fair Board's asset list.

IT IS FURTHER RESOLVED that Bus # 310 and Bus #410 referenced above be, and hereby are, declared to be surplus property, and in accordance therewith, said vehicles shall be sold at public auction to the highest bidder in accordance with *Idaho Code* §31-808 and be removed from the County's list of assets.
