

Resolution 2018-42
Surplus Vehicle Equipment/Asset Deletion/KCSO

WHEREAS, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County, and;

WHEREAS, *Idaho Code* §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and

WHEREAS, the Kootenai County Sheriff's Office has in its possession the following items of law enforcement equipment, to-wit:

- one (1) P-25 Motorola Mobile Radio
- one (1) Radar unit & assembly
- one (1) Push bumper
- one (1) Plexiglass divider
- one (1) Trunk organizer
- one (1) Light bar
- one (1) Camera

Said equipment is listed collectively as Asset Tag No. 4518-5 on the Kootenai County Auditor's Asset Data Sheet, a copy of which is attached hereto as Exhibit "A"; and

WHEREAS, the cost of the equipment referenced hereinabove at the time of purchase totaled \$15,862.69, and at the present time, the equipment has fully depreciated and has no monetary value; and

WHEREAS, it is the desire of the Kootenai County Sheriff's Office to retain the P-25 Motorola Mobile Radio for future installation into another law enforcement vehicle, and utilize all of the other items of equipment for parts; and

WHEREAS, the Kootenai County Sheriff's Office desires to have the above referenced items declared as surplus property and removed from the County's list of assets which is managed by the Kootenai County Clerk/Auditor;

NOW THEREFORE, IT IS HEREBY RESOLVED that the items referenced hereinabove be, and hereby are, declared to be surplus property, and in accordance therewith, the Board of County Commissioners hereby authorizes the Sheriff's Office personnel to utilize said items for parts or otherwise, as deemed appropriate.

BE IT FURTHER RESOLVED that the Board of County Commissioners authorizes removal of the items referenced hereinabove from the County's list of assets which is managed by the Kootenai County Clerk/Auditor.
