

**RESOLUTION NO. 2011- 50**  
**SURPLUS PROPERTY**  
**Board of Commissioners**

**WHEREAS**, *Idaho Code* §31-807 vests the Board of County Commissioners with the power and authority to manage real and personal property for the benefit of the County; and

**WHEREAS**, *Idaho Code* §31-829 provides that whenever any elected official has any personal property belonging to the county under his/her jurisdiction or control which, in his/her judgment, is of no further use to the county, he/she may, with the consent of the Board of County Commissioners, have the property declared as surplus and dispose of the property through sale or other means; and,

**WHEREAS**, *Idaho Code* §31-808 provides that personal property not exceeding \$250.00 in value may be sold at private sale without notice or public auction; and,

**WHEREAS**, the Kootenai County Board of Commissioners is in possession of excess office furniture, fixtures & equipment (see Exhibit A) attached hereto and made a part hereof by reference which is either new, in poor condition or is not practical to use by the County; and

**WHEREAS**, it would not be cost effective for Kootenai County to maintain the office furniture/equipment, thereby rendering it useless to the County; and,

**WHEREAS**, in its present condition, each piece of furniture/equipment specifically identified in 'Exhibit A', in its present condition, has a value of less than \$250.00; and,

**WHEREAS**, the Kootenai County Board of Commissioners desires to have the above-referenced office equipment/furniture declared as surplus property;

**NOW THEREFORE**, it is hereby resolved that the property described in Exhibit 'A' attached hereto be, and hereby is, declared to be surplus property, and, in accordance therewith, the Board of County Commissioners may take action to dispose of said property by public or private sale upon such terms and conditions as the County deems necessary in accordance with Idaho law.

Upon a motion to adopt the text of the foregoing Resolution made by Commissioner Nelson seconded by Commissioner Green, the following vote was recorded:
